## LIMITED PRODUCT WARRANTY

This Limited Product Warranty ("<u>Warranty</u>") gives you specific legal rights, and you may also have other rights which vary from state to state. For this Warranty to be effective the original end-use purchaser must send the following information to <u>warranty@thermoryusa.com</u> within ninety (90) days of the original purchase date of the Product:

- i. a copy of the receipt for the purchase of the Product;
- ii. name, address, phone number, and email address of the installer of the Product; and
- iii. name, address, phone number, and email address of the original end-use purchaser.

THERMORY USA, INC., a Delaware corporation ("<u>Thermory</u>"), expressly warrants to the original end-use purchaser that, for the period ("<u>Warranty Period</u>") set forth next to the applicable product ("<u>Product</u>") on Schedule A attached to this Warranty ("<u>Schedule A</u>"), the Product will be reasonably free of defects caused by soft-rot fungi and wood-decay fungi in excess of the parameters set forth in the Product specifications posted at <u>www.thermoryusa.com</u> as of the original purchase date, subject to the exclusions set forth herein.

If the Product does not perform as warranted herein within the Warranty Period, Thermory will, at its option, (1) replace the Product, subject to the limitations set forth below, or (2) refund a portion of the Product cost in accordance with the applicable schedule set forth on Schedule A.

Replacement of the Product during the Warranty Period shall include reasonable delivery charges necessary to deliver the replacement product, but shall not include any other costs or services, including, without limitation, removal of the defective Product and installation of the replacement product. Thermory's obligation to replace the Product shall further be limited to replacement with the Product materials available at the time of replacement; the Product is made of natural material and, as such, natural variability of texture and appearance are inherent in the Product, such that the replacement Product shall not be identical to the defective Product. Furthermore, Thermory's obligation hereunder regarding the defective Product is limited only to that portion of the specific Product that fails the Warranty hereunder. Any replacement product shall be subject to the original Warranty and shall not extend the original Warranty Period in any manner or start a new warranty period.

You may obtain coverage under this Limited Warranty by providing to Eric Britson, Product Development Manager, or his or her designee, at warranty@thermoryusa.com or 585-250-4074 within 14 days after discovery of the defect, (i) a statement describing the defect, (ii) photographs sufficient to identify the defect(s), (iii) a copy of this Certificate of Warranty, (iv) copies of relevant purchase invoices of the subject Product, and (v) your name and contact information.

#### **Warranty Exclusions**

This Warranty applies only to a Product used, stored, handled, fabricated and installed, as applicable, in the manner recommended by Thermory.

Thermory's Products must be stored, handled, installed, used and maintained in accordance with instructions provided by Thermory, and this Warranty is conditioned upon compliance with all such instructions. Copies of Thermory's instruction manuals and recommendations

are available for the dealer, distributor of purchase or through Thermory directly at <a href="https://www.thermoryusa.com">www.thermoryusa.com</a> or by contacting at 1-585-250-4074.

This Warranty does not cover defects caused by:

- 1. Non-compliance with Thermory's Cladding Installation Guide, Decking & Porch Flooring Installation Guide, Cornering Options Installation Guide, Maintenance & Care Manual, Herringbone Decking Installation Guide;
- 2. Improper storage, installation, handling, transportation, use and/or fabrication of the Product;
- 3. Normal wear and tear, including, without limitation, natural color change due to normal weathering (such as natural efflorescence, exposure to sunlight, weather and atmospheric conditions, which causes any colored or wood surface to gradually fade, chalk or accumulate dirt or stains);
- 4. Use of Products beyond normal use or in an application not recommended or permitted by Thermory's instructions or manuals, applicable laws or building codes;
- 5. Failure to abide by applicable laws or building codes, including, without limitation, improper structural support or fastening;
